Biographical Sketch

Robah O. Kellog (1920-2013) attended Cook County School of Nursing and the University of Michigan for an MPH. She earned a public health nursing certificate at the University of Minnesota. Kellog served in the US Public Health Service Agency in Iran and Korea and later taught at the UIC College of Nursing in Peoria. .

Scope and Contents

Collection relates mainly to Robah Kellog's work as a public health nurse educator—many booklets and books related to public health nursing in the 1950s to 1980s.
